Wasco Schools Technology, which is a consortium effort between Wasco Union Elementary District and Wasco Union High School District, is operated in a "virtual K-12" format for all technology needs. This cooperative effort allows both districts to share technology infrastructure, and staff, lowering the overall cost of technology for each district.

Wasco Schools Technology implemented Eagle Software's Aeries Student Information System in the fall of the 1998-1999 school year. Using a DOS based software for 10 years, the move to Aeries was a challenge. After evaluating Aeries and two other software offerings, Aeries was determined to be the best-fit package for our needs.

The criteria used during the evaluation process for a replacement SIS were:

- Windows GUI-based platform
- Ability to maintain both elementary and secondary school formats
- Easily customizable to allow flexibility with changing needs
- Low cost of ownership
- Online support

• Regular upgrades for new features and fixes to bugs in the software

Eagle Software assisted the implementation/conversion by converting all data from the old software to the new, and provided an onsite trainer to get the school office staff up and running. One of the largest hurdles was to get the classroom attendance module up and running at the same time as the front office. Hindsight being clearer than foresight, we should have implemented the new software in the front office during the first half of the year and the classroom attendance during the second half.
